Articles of Incorporations

The undersigned, for the purpose of forming a not for profit corporation under the laws of the State of Florida, do hereby adopt the following articles of incorporation:

ARTICLE ONE

ARTICLE THREE - PURPOSE

The specific purpose for which the corporation is organized is to perform charitable work for persons in need in our community and to promote interest in ownership, riding and safety for persons who ride motorcycles and:

(1). To engage in any other trade or business which can, in the opinion of the board of directors of the corporation, be advantageously carried on in connection with or auxiliary to the foregoing business.

(2). To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.

ARTICLE FOUR - MANNER OF ELECTION

The manner in which the directors are elected is as follows:

Elections are to be held bi-annually at the club's regular meeting in December of the election year. Candidates for officer positions receiving the highest number of votes shall be elected to a term of two years. A ballot vote will be required when there are two or more nominations per office. A voice vote is sufficient for one nomination per office. Voting by proxy is permitted.






