### ARTICLE I

### Name

The name of the corporation shall be FRIENDS OF FRIENDS ANIMALS RESCUE AND SANCTUARY INC.

### ARTICLE II

## Principal Office

Its principal place of business and mailing address shall be 13446 S.W. 62<sup>nd</sup> Street, # E108, Miami, Florida 33183.

### ARTICLE III

### **Purposes**

The general purposes for which the corporation is organized is:

- (1) To rescue homeless and abandoned pets; and
- (2) To educate the public on the importance of spaying and neutering animals; and
- To offer free spaying and neutering of animals for pet owners or rescuers; and (Low ω ω ω ω ω)
- (4) To bring the numbers of homeless cats and dogs down both in the City of Miami and Dade County by finding homes for abandonned pets; and
