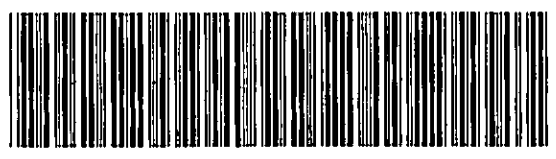




B. 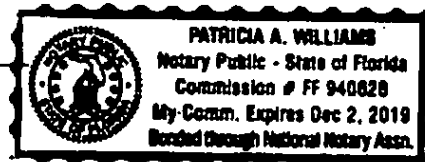
