ARTICLES OF INCORPORATION OF SOBE SOFTBALL, INC. (A Nonprofit Corporation)

The undersigned hereby executes these Articles of Incorporation for the purpose of becoming incorporated under the laws of the State of Florida Not for Profit Corporation Act as a nonprofit corporation and certifies as follows:

ARTICLE I

Name

The name of the Corporation shall be SOBE SOFTBALL INC. Its principal office shall be at 16440 84TH Court, North, Loxahatchee, FL 33470 or at such other place as may be designated, from time to time, by the Board of Directors.

ARTICLE II

Duration

The period of duration of the Corporation is perpetual.

ARTICLE III

Purpose and Powers

The sole purpose of the Corporation is to operate a softball league for the pleasure and recreation of its members, their families and their guests. The Corporation is organized exclusively for social, pleasure, recreation and other nonprofitable purposes. The Corporation shall be empowered to acquire, rent, lease, let, hold, own, buy, convey, mortgage, bond, sell or assign property, real, personal or mixed, and to borrow money, whether secured or unsecured, and to do and perform all such other acts and things as are allowed by the laws of the State of Florida with respect to nonprofit corporations, as those laws now exist or as they may hereafter provide.

ARTICLE IV

Manner of Election of Board of Directors

There shall be a Board of Directors consisting of at least one (3) individuals. The initial

Director is elected by the Incorporator. Thereafter, each Director shall be elected by majority vote of the Board of Directors in the manner and at the times set forth in the Bylaws.

ARTICLE V
