THE BOARD OF DIRECTORS OF FARRIS H. DAVIS POST 299 AMERICAN LEGION, INC.- JIM HENSON, BOB HYER AND BOB STATON-- MOVE THE ADOPTION OF THE FOLLOWING RESOLUTION AMENDING THE ARTICLES OF INCORPORATION TO WIT:

### ARTICLE IX-- SALE OF POST#299 REAL PROPERTY

SECTION 1. ANY OFFER TO PURCHASE THE POST REAL PROPERTY, DEEMED BY THE EXECUTIVE COMMITTEE TO BE WORTHY OF CONSIDERATION, SHALL BE FORWARDED TO THE AMERICAN LEGION, DEPARTMENT OF FLORIDA, TOGETHER WITH A COPY OF THE OFFER IN WRITING, NOT LATER THAN 30 DAYS PRIOR TO THE PROPOSED DATE FOR CLOSING.

SECTION 2. THE POST ADJUTANT SHALL NOTIFY ALL ACTIVE MEMBERS (DUES PAID IN FULL) BY UNITED STATES POSTAL SERVICE, RETURN RECEIPT REQUESTED, THAT AN OFFER TO PURCHASE HAS BEEN RECEIVED AND WILL BE CONSIDERED ON A DAY, TIME AND PLACE CERTAIN, ALLOWING SUFFICIENT TIME FOR PLANNING. THIS ITEM WILL BE THE ONLY MATTER FOR DISCUSSION ON THE AGENDA.

SECTION 3. PRIOR TO VOTING THE COMMANDER OR HIS DELEGATE SHALL NAME TWO MEMBERS IN ATTENDANCE TO ACT AS TELLERS TO COUNT VOTES. VOTING SHALL BE BY PAPER BALLOTS BEARING ONLY THE "FOR" OR "AGAINST" OPTIONS AND ANY BALLOTS RETURNED BLANK SHALL NOT COUNT IN THE TOTAL OF VOTES CAST. IN ORDER FOR AN OFFER TO BE APPROVED, IT MUST RECEIVE NOT LESS THAN 67 PER CENT VOTES IN THE AFFIRMATIVE.
