Article I:

Name of Corporation: Radnicki Social and Football Club, Inc. ("RSFC, Inc.").

Article II:

Article III:

(A) **Statement of General Purpose:** Radnicki Social and Football Club, Inc. is established and incorporated to provide a cultural umbrella for the different peoples of our community, to embrace the values of their country of birth, and to introduce to its members the values, privileges, and responsibilities of living in the United States of America.

(B) **Statement of Specific Purposes:** In order to further its general purpose, Radnicki Social and Football Club, Inc. shall work:

(1) To seek and accept members regardless of race, color, national origin, religion, gender, or age.

(2) To collect dues and membership fees as set and approved by the vote of the majority, to provide the means and facilities necessary to sustain the Club.

(3) To provide volunteer workers from its members to help and assist in worthy causes and to fulfill the emergency needs of our community during natural or other disasters.

(4) To gather supplies to provide relief to needy members of families during times of need.

(5) To organize events to celebrate national holidays and festivities to introduce new members of the community to the American traditions and times to honor and pay homage to its heroes.

(6) To provide foods, snacks, and refreshments during some of these events with monies and supplies contributed by members and donors of the community.

(7) To gather, print, and distribute information of legal and general interest to members, community and speakers of language other than English to speed

and increase their knowledge and fluency in English.

(8) To provide information and coordinate activities for the access of the elderly or disabled members of our community.

(9) To support the needs and requirements of a football (soccer) team to represent the various nationalities and races of the families and individuals, members of the community, and of this club.

(10) To provide assistance and support for members engaged in other sports or activities of their interest or choosing.

(11) To provide personnel and coaches to train and develop the knowledge and skills of member players and participants in activities in amateur competition and enable them to proudly and ably represent our country and community.


