**ARTICLE I**

The name of this Corporation shall be WORKSHOP DANCE COMPANY, INC.

**ARTICLE II**

This corporation is incorporated under Chapter 617, Florida Statutes, as a Corporation Not for Profit.

**ARTICLE III**

This corporation shall exist in perpetuity.

**ARTICLE IV**

The street address of this Corporation shall, initially, be 9430 So. U. S. Highway One, Port St. Lucie, Florida 34952.

**ARTICLE V**

The purpose of this entity is to provide an avenue for those interested in dance to perform their craft and achieve additional experience to advance their career. The entity will also provide scholarship opportunities for those interested in furthering their education in dance.

#### **ARTICLE VI**

The incorporator and initial director of the Corporation is MICHAEL D. ELMORE, whose address is as shown in Article IV, above. The method of electing directors shall be as stated in the By-Laws of the Corporation. The Corporation shall have three (3) directors initially, which may be increased or diminished from time to time by the By-Laws of the Corporation, but shall never be less than three (3) directors.

#### **ARTICLE VII**


The name of the registered agent of this Corporation shall be MICHAEL D. ELMORE, whose street address is shown in Article IV, above.

By his signature below, such Registered Agent hereby affirms that he is aware of his duties as Registered Agent for said Corporation.

#### **ARTICLE VIII**

Provisions for the regulation of the internal affairs of the Corporation, including, but not limited to, any provisions with respect to the relative rights or interests of the members as among themselves or in the property of the Corporation, the manner of termination of membership in the Corporation, the rights upon termination of membership in the Corporation, the terminated members and the remaining members, the transferability or non-transferability of membership in the Corporation, the distribution

of assets upon dissolution or final liquidation, and classes of membership shall be stated in the By-Laws of the Corporation.

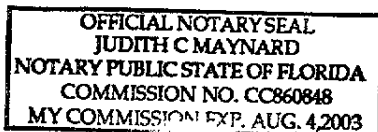
