The undersigned does hereby execute, acknowledge and file the following Amendment to the Articles of Incorporation of GILBERT'S ANGELS BIBLE COLLEGE, INC.

1. The name of the Corporation is currently:

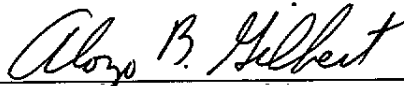
GILBERT'S ANGELS BIBLE COLLEGE, INC.
2. The date of the filing of the Articles of Incorporation was February 7, 2001.
3. The Articles of Incorporation are amended as follows:
 - a. By deleting all of Article I hereof, and by substituting in lieu thereof, all of the following:

"The name of the corporation shall be GILBERT BIBLE COLLEGE, INC. Its principal place of business shall be 10875 Quail Roost Drive, Miami, Florida 33157, and the mailing address shall be 10875 Quail Roost Drive, Miami, Florida 33157, County of Miami-Dade, State of Florida. The Corporation shall have the power and authority to establish branch offices at such place or places as may be designated by the officers and directors."
 - b. In all other respects, the Articles of Incorporation shall remain unchanged.
4. This Amendment was adopted by a written statement signed by the directors of GILBERT'S ANGELS BIBLE COLLEGE, INC. on April 7, 2001 pursuant to Section 617.1006 of the Florida Statutes as there are no members of this Corporation.
5. The effective date of this Amendment shall be upon the filing of these Articles of Amendment to Articles of Incorporation with the Secretary of State of the State of Florida.
