

**ARTICLE I:** The name of the corporation shall be, Ridge Area Radio Support Group, inc.

**ARTICLE II:** The principal place of doing business shall be 1245 West McLeod Street, Bartow,  
Florida 33830-6234

**ARTICLE III:** The purpose of the Ridge Area Radio Support Group, Inc. shall be:

- (1) To provide an outlet for public service broadcasting by government, civic Associations, charitable and other non-profit organizations.
- (2) To provide educational broadcasting opportunities for school-sponsored athletic and other programs which otherwise would not be covered by the broadcast media in the area.
- (3) To provide affordable broadcasting opportunity for the worship services of Religious organizations in Bartow, Florida
- (4) To provide educational information on the technical aspects of radio broadcasting for students in schools and other interested persons.
- (5) To provide an introduction to working in broadcasting for students and Other persons interested in careers in this area. This also applies to Amateur Radio (Ham) classes.
- (6) To work closely with the Polk County Historical Museum and county Historical groups to further educate the local citizens as to the rich History of the county.
- (7) To provide programs and news to meet the listening interest of persons who Otherwise who would have no other source for their programming interest.
- (8) If requested to assist, to provide emergency notices and similar information In times of local emergency or natural disaster.
- (9) To educate the local listeners with new laws and environmental issues that have or will go in law that will effect them.

**ARTICLE IV:** The directors shall be elected or reconfirmed at the annual meeting to take place on the second Tuesday in January of each calendar year, unless notified ten (10) days in advance by registered mail.
