The undersigned , for the purpose of forming a Non-profit corporation pursuant to Florida Law, section 617 hereby certifies as follows:

ARTICLE I  
NAME

The name of this Corporation Not for-Profit shall be:

ARTICLE II  
PURPOSE

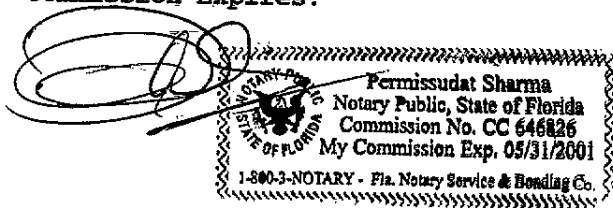

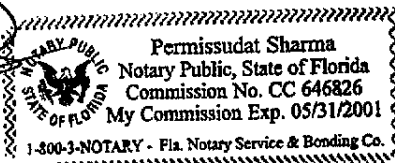
