The undersigned, resident of Florida, desiring to form a not-for-profit corporation in compliance with Chapter 617.F.S. (Not for Profit) does hereby execute these Articles of Incorporation.

ARTICLE I. NAME

The name of the Corporation shall be:

INTERCOASTAL DETACHMENT NO. 1058 MARINE CORPS LEAGUE, INC.

ARTICLE II. PRINCIPAL OFFICE

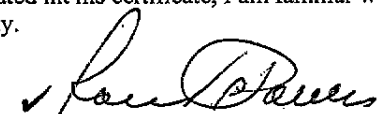

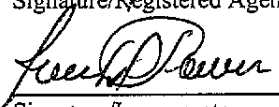

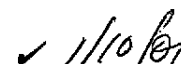
