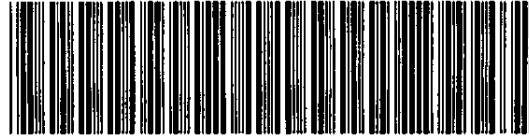

**ADDING ARTICLE XIV: Statement of our Christian Faith**

**MINISTERIO EVANGELISTICO VINO NUEVO INC, BELIEVE:**

- (1): We believe that God is our creator of the universe creating both of the seen (physical) and the unseen (spiritual) realms and that God is also the giver of life.
- (2). We believe the Holy Bible is God's word personally spoken by God for mankind for the purpose of reveling who He is and it is without error in all issues to which it speaks. We believe the Holy Bible is the only and infallible rule of faith and conduct.
- (3). We affirm that the inspiration of the Holy Spirit gives the Bible its canonical authority, and the role of the church is to recognize and affirm this authority. We affirm that our church is subject to the Word of God in their order as in their doctrine.
- (4). We believe that all human life is sacred and created by God in His image. Human life is of inestimable worth in all its dimensions, including pre-born babies, the aged, the physically or mentally challenged, and every other stage or condition from conception through natural death. We are therefore called to defend, protect, and value all human life (Psalm 139)

**Statement on Marriage, Gender, and Sexuality**

- (1). We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Gen 1:26-27.) Rejection of one's biological sex is a rejection of the image of God within that person. Man and women are created by God in His image and likeness and their should not reject their biological sex.

### **ADDING ADDITIONAL ARTICLES**

#### **ARTICLE XV: Statement of Christian Faith on Marriages, Gender and Sexuality**

##### **MINISTERIO EVANGELISTICO VINO NUEVO INC, BELIEVES:**

(1): We believe that God wonderfully and immutably creates each person as male or female. These two distinct, complementary genders together reflect the image and nature of God. (Gen 1:26-27.) Rejection of one's biological sex is a rejection of the image of God within that person. Man and woman are created by God in His image and likeness and there should not reject their biological sex.

(2): We believe that the term "marriage" has only one meaning: the uniting of one biological man and one biological woman in a single, exclusive union, as delineated in Scripture. (Gen 2:18-25.) We believe that God intends sexual intimacy to occur only between a biological man and a biological woman who are married to each other. (1 Cor 6:18; 7:2-5; Heb 13:4.)

(3): We believe that God has commanded that no intimate sexual activity be engaged in outside of a marriage between a man and a woman.

(4): We believe that any form of sexual immorality, including adultery, fornication, homosexual behavior, bisexual conduct, bestiality, incest, and use of pornography, is sinful and offensive to God. (Matt 15:18-20; 1 Cor 6:9-10.)

(5): We believe that in order to preserve the function and integrity of our church as the local Body of Christ, and to provide a biblical role model to our members, and the community, it is imperative that all persons employed by our church in any capacity, or who serve as volunteers, agree to and abide by this Statement on Marriage, Gender, and Sexuality. (Matt 5:16; Phil 2:14-16; 1 Thess 5:22.)

(6): We believe that God is merciful to all sinners. He offers redemption and restoration to all who confess and forsake their sin, seeking His mercy and forgiveness through Jesus Christ. (Acts 3:19-21; Rom 10:9-10; 1 Cor 6:9-11.)

(7): We believe that every person must be afforded compassion, love, kindness, respect, and dignity. (Mark 12:28-31; Luke 6:31.) Hateful and harassing behavior or attitudes directed toward any individual are to be repudiated and are not in accord with Scripture nor the doctrines of our church.

(8): We believe that God has ordained marriage and defined it as the covenant relationship between a man and a woman, and Himself, our church only recognize marriages between a biological man and a biological woman.

(9): We believe that senior pastor, the assistant pastors, ministers, staff and volunteer of our church shall only participate in weddings and solemnize marriages between one biological man and one biological woman that are members in good standing of our church. The senior pastor should marriage only staff members that have been active for at as least two years. The assistant pastors should marriage only active members of our congregation.

(10): **MINISTERIO EVANGELISTICO VINO NUEVO INC** believes that the facilities and properties of our church shall only host weddings between a biological man and a biological woman.

### **ADDING ADDITIONAL ARTICLES**

#### **ARTICLE XVI: Statement of Church Membership Policy.**

#### **MINISTERIO EVANGELISTICO VINO NUEVO INC BELIEVES:**

(1): We believe that membership of our church is a privilege and shall be composed only of individuals who are believers in the Lord Jesus Christ and affirm the tenets of the Church Statement of Faith, and the church's Statement of Faith on marriage. Gender and Sexuality.

(2): We believe that all members should offer evidence, by their confession and their conduct, that they are living in according to the rule of faith and conduct of the Holy Bible and our church's Statement of Faith.

(3): We believe that all to carry on the religious mission of the church, to preserve the function and integrity of the church as the local Body of Christ, and to provide a biblical role model to the church members and the community, it is imperative that all persons who associate with the church as members should abide by and agree to the church's statement of membership policy.

(4): We believe the Lord Jesus Christ has entrusted the local church with the authority and responsibility to discipline members to flagrant sin or serious doctrinal error, with the goal of restoration of the

offender. This discipline is entrusted to the Pastoral Staff and is to follow the biblical pattern as set forth in Matthew 18:15-20; I Corinthians 5; II Corinthians 2:7-8; Galatians 6:1; II Thessalonians 3:6; Titus 3:10-11 and II John 7:11

(5): We believe discipline will follow the biblical pattern described on paragraph 4, and is an effort to bring the individual to repentance and protect the church from unrepentant sin. Discipline may involve exclusion from participation in ministry and communion, as well as dismissal from the fellowship of our church.

(6): **MINISTERIO EVANGELISTICO VINO NUEVO INC** believes that in order for an individual to apply for membership they should have been for at least two (2) years attending our services and must have a conduct according to the Holy Bible.

### **ADDING ADDITIONAL ARTICLE**

#### **ARTICLE XVII: Statement of Religious Employment**

##### **MINISTERIO EVANGELISTICO VINO NUEVO INC BELIEVES:**

(1): We affirm that the inspiration of the Holy Spirit gives the Bible its canonical authority, and the role of the church is to recognize and affirm this authority in all aspect and activities of the church. The church affirms and projects that authority also by its employees and volunteers.

(2): We believe that all and every position within the church, employees and volunteers, furthers the church's religious mission and has to be filled by a person that his/her life is inspired and reflect the doctrine of faith and conduct according to the Holy Bible and the church's Statement of Faith.

(3): We believe that all and every employee and volunteer of the church is a minister and therefore has to agree, support and lives according to the church Statement of Faith.

(4): **MINISTERIO EVANGELISTICO VINO NUEVO INC** believes that the "ministerial exemption" is legal doctrines that clearly state that church is exempt from anti-discrimination laws in hiring employees.

### **ADDING ADDITIONAL ARTICLE**

#### **ARTICLE XVIII: Statement on Church Facility Use Police**

##### **MINISTERIO EVANGELISTICO VINO NUEVO INC BELIEVES:**

(1): We believe the church's facilities, land, patios, front and backyard, and equipments were provided through God's benevolence and by sacrificial generosity of church members and volunteers. The church's

facilities are used only for the fellowship of the Body of Christ and to bring God glory. The church's facilities are not open to the public.

(2): We believe that the church's facilities use would not be permitted to persons or groups holding, advancing, or advocating beliefs or practices that conflict with the church's statement of faith or moral teaching that are summarized in the Articles of Incorporations.

(3): We believe that in no event shall persons or groups who hold, advance or advocate beliefs or advance or engage in practices that contradict the church's faith use any church's facilities. The church's facilities should not be used in any way that contradicts the church's statement of faith.

(4): **MINISTERIO EVANGELISTICO VINO NUEVO INC** believes that this policy applies to all church's facilities, regardless of whether the facilities are connected to the church's sanctuary or are not, because the church sees all of its property as holy and set apart only to worship God. (Colossians 3:17)
