ARTICLES OF INCORPORATION

The undersigned person, acting as incorporator of a corporation organized under the laws of Florida, hereby adopt(s) the following Articles of Incorporation:

ARTICLE I CORPORATE NAME

The name of this corporation is K9 Community Assistance Network, Inc..

ARTICLE II INITIAL PRINCIPAL OFFICE

ARTICLE III MANNER OF ELECTION

The manner in which the directors are elected and appointed is at the discretion of a majority vote of the initial members of the Board of Directors.

ARTICLE IV REGISTERED OFFICE AND AGENT

ARTICLE V PURPOSE

The purpose for which the corporation is organized is to assist the handicapped community, through an IRS section 501(c)(3) non-profit organization, by providing quality, highly trained assistance dogs, while benefitting as many other members of the community through the training and placement process as possible.

After the initial board of directors, the board shall consist of such number of directors as shall be determined by the initial board of directors from time to time at each annual meeting at which directors are to be elected.

ARTICLE VII LIABILITY OF DIRECTORS

To the fullest extent permitted by law, no director of this corporation shall be personally liable to the corporation for monetary damages for breach of any duty owed to the corporation except that a director may be held personally liable for (i) breaches of the duty of loyalty, (ii) acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or (iii) a transaction from which the director derives an improper personal benefit.

Any director or officer who is involved in litigation or other proceeding by reason of his or her position as a director or officer of this corporation shall be indemnified and held harmless by the corporation to the fullest extent permitted by law.

ARTICLE VIII OTHER PROVISIONS

<u>Director or Officer Interest.</u> In the absence of fraud, no transaction between (a) this corporation and (b) any other association, corporation or any director or officer of this corporation individually, shall be affected by the fact that any director or officer of this corporation is individually a party to the transaction or is interested in or is a director or officer of such other association or corporation.

<u>Corporate Seal.</u> The corporation shall have a corporate seal, which shall be affixed to all documents requiring a corporate seal.

<u>Execution of Written Instruments</u>. All instruments that are executed on behalf of the corporation may be executed by any officer(s) or agent(s) that are specifically designated by resolution of the board of directors.
