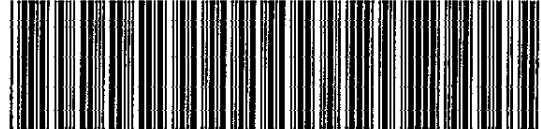





The name of the Corporation is **ITALIAN CULTURAL HERITAGE CENTER OF NAPLES, INC.**, (hereinafter "Corporation").


*AMEND TO:* **ARTICLE 1 – NAME**
