Please return the original and one copy of your document, along with a copy of this letter, within 60 days or your filing will be considered abandoned.

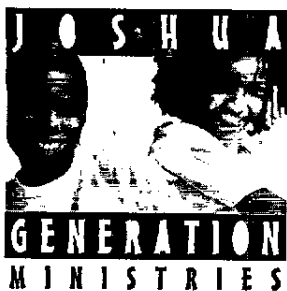
