**ARTICLES OF INCORPORATION**

**OF**

**JAZZ EDUCATORS, INC.**

The undersigned, incorporate, for the purpose of forming a corporation under the Florida Business Corporation Act, Chapter 6/7 of the Florida Statutes, hereby adopts the following Articles of Incorporation:

**ARTICLES I: NAME OF THE CORPORATION**

The name of the corporation is:

hereinafter referred to as the "Corporation".

**ARTICLE II: PRINCIPAL OFFICE AND MAILING ADDRESS**

**ARTICLE III: PURPOSE OF THE CORPORATION**
