**ARTICLES OF AMENDMENT
OF
MARANATHA CHRISTIAN CENTER OF
POMPANO BEACH, FLORIDA, INC.**

The undersigned incorporator(s), for the purpose of amending the Articles of Incorporation under the Florida Not for Profit Corporation Act, hereby adopt(s) the following amendments to the Articles of Incorporation:

**ARTICLE I:
NAME**

The name of the corporation shall be:

MARANATHA CHRISTIAN CENTER OF POMPANO BEACH, FL, INC.

**ARTICLE II:
PRINCIPAL OFFICE**

**ARTICLE III:
AMENDMENTS TO PURPOSES**

I. The purposes for which the corporation is organized are exclusively religious and charitable within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law. The corporation shall engage in all activities necessary to accomplish these purposes, including, but not limited to:

- A. The preaching and teaching of the Gospel of the Lord Jesus Christ according to the Holy Bible.
- B. The operation of ministries necessary to the accomplishment of Article IIIA as herein stated.
- C. The establishment of clergy and other Biblical offices and appointments in accordance with Biblical procedures.

D. The establishment of a Constitution and By-Laws essential to the ministries of
Maranatha Christian Center of Pompano Beach, Florida, Inc.

II. Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

III. Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any assets not so disposed of shall be disposed of by the Court of Common Pleas, of the county in which the principal office of the corporation is then located, exclusively for such purposes.

ARTICLE IV:
DIRECTORS

The pastor of Maranatha Christian Center is the chief executive officer. The manner of election for further directors shall be as appointments, until there is an election of deacons or officers according to the church's By-Laws.

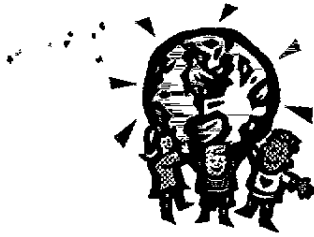
