ARTICLE I

The name of the corporation is RAULERSON HOSPITAL MEDICAL STAFF, INC.

ARTICLE II

This corporation shall have perpetual existence, commencing as of the time these ARTICLES are filed by the Department of State, Division of Corporations.

ARTICLE III

This corporation is being formed as a "Not for Profit" Corporation under Section 617.0301, Florida Statutes, for the purpose of advancing the health and well-being of the public of this area through professional and educational means and facilities. The membership of the corporation will be composed of M.D. and D.O. physicians, allied health personnel and medical associates as admitted to the Raulerson Hospital Medical Staff. Eligibility for membership in the corporation will be determined by the credentialing process set out in the By-Laws adopted by the Medical Executive Committee of the Raulerson Hospital Medical Staff and effective as of January 1, 2001, and as amended.

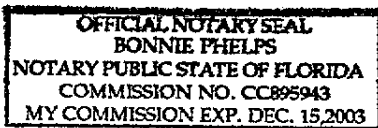
ARTICLE IX

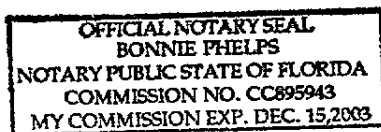
