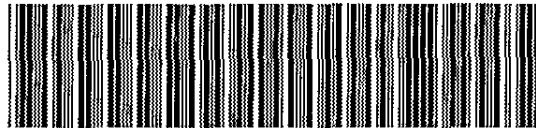

ARTICLES OF AMENDMENT

OF

UPWARD BOUND YOUTH FOUNDATION, INC.

First: The Articles of Incorporation of UPWARD BOUND YOUTH FOUNDATION, INC. are hereby amended to add the following separate section:

Upon dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or shall distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the Court of Competent Jurisdiction for the county in which the principal office of the corporation is then located, exclusively for such purpose or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

Second: The date of the adoption of the amendment is November 27, 2002.

Third: There are no members or members entitled to vote on the amendment. The Amendment was adopted by the unanimous vote of the Board of Directors.
