#### ARTICLE I NAME

The name of this Assembly shall be River of Life Assembly, Oviedo, INC.

## ARTICLE II PLACE OF BUSINESS

The principal place of business and mailing address of this corporation shall be:

### ARTICLE III PUPOSE

The purpose for which the corporation is organized is: For the purpose of establishing and maintaining a place for the worship of Almighty God, our Heavenly Father; to provide for Christian fellowship for those of like precious faith, where the Holy Ghost may be honored according to our distinctive testimony; to assume our share of responsibility and the privilege of propagating the Gospel of Jesus Christ by all available means, both at home and in the foreign lands.

## ARTICLE IV ELECTION OF DIRECTORS OR APPOINTMENT

Section 1. The Pastor shall be considered as the spiritual overseer of the Assembly and shall direct all of its activities. He shall be the president of the corporation and shall be the presiding officer of all business meetings of the Assembly and of the Board. He shall be an exofficio member of al committees or departments. He shall provide for all the services and shall arrange for all special meetings, convention or revival campaigns. No person shall be invited to speak or preach in the Assembly without his approval. The Pastor is elected b the congregation with an acceptance vote of 75% or higher.

Section 2. The Board, in addition to the Pastor shall consist of at least three members chosen from the membership of the church. They shall transact all routine business of the church; shall be the custodians of all property of the corporation and shall be responsible for maintenance and cleanliness of same. They are chosen to serve the church and therefore shall act in an advisory capacity with the Pastor in all matters pertaining to the Assembly in its spiritual life and in the ministry of its ordinances. They shall act in the examination of applicants for membership, at the request of the Pastor; and also in the administration of discipline to the members of the Assembly. A majority present at any meeting of the Board shall constitute a quorum, provided all the members have been notified to be present. An individual is nominated to the board, and than voted on by the congregation, and a simple majority is needed for election.

Section 3. The Secretary shall keep the minutes of the official meetings of the Board and of the business meetings of the Assembly. He shall supervise the keeping of the membership roll of the Assembly and the performance of any other clerical work necessary to the proper discharge of his duties. He shall supervise the safekeeping of all legal documents and the corporate seal. The Secretary is appointed by the Pastor and the Board.

Section 4. The Treasurer shall be entrusted with all the finances of the Assembly, He shall supervise the depositing of all funds in a bank designated by the Board, in the name of the Assembly, and shall be disburse the same by check as authorized by the Board. All checks will be signed by the Treasurer and Co-signed by the Pastor. In the event either or both of the above are unable to sing, two designated Board members shall be authorized to sign checks. A fund to handle operating expenses shall be established under the supervision of the Treasurer. The Bookkeeper, Treasurer, or the Pastor shall be authorized to sign checks to a limit established by the Board.

The Treasurer shall be responsible for supervising the maintenance of an itemize account of all receipts and disbursements. He shall make an itemized written report monthly at the regular meeting of the Board and a summarized written report with copies furnished to the members of the Assembly at its annual business meeting. His accounts shall be audited annually under the direction of the Board. All signers of checks may be bonded at the discretion of the Board. The Treasurer is appointed by the Pastor and the Board.
