#### ARTICLES OF INCORPORATION

OF

### KINGSTON ACADEMY, INC.

The undersigned incorporator to these Articles of Incorporation hereby forms a Not For Profit corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of the corporation shall be Kingston Academy, Inc.

#### ARTICLE II - TERM OF EXISTENCE

This corporation shall exist in perpetuity.

#### ARTICLE III - PURPOSES

- 1. The purposes for which the corporation is to be formed are exclusively to receive and administer for educational and charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended and to that end to hold any property, or any undivided interest therein, without limitation as to amounts or values; to dispose of any such property and to invest, reinvest or deal with the principal or in the income in such a manner as, in the judgment of the directors, will best promote the purposes of the corporation without limitation, except such limitations, if any, as may be contained in the instrument under which such property is received, these Articles of Incorporation, the Bylaws of the Corporation, or any applicable law; to do any other act or thing incidental to or connected with the foregoing purpose or in advancement thereof, but not for the pecuniary profit or financial gain of its members, directors or officers except as permitted under the Florida Corporation not-for-profit law.
- 2. No part of the net earnings of the corporation shall inure to the benefit of any member, director, trustee, or officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the corporation affecting one or more of its purposes), and no member, director, trustee or officer of the corporation, or any private individual shall be entitled to share in the distribution of any of the corporate assets on the dissolution of the corporation. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence such legislation, and the corporation shall not participate in nor intervene (including publication or distribution of statements) in political campaign on behalf of any candidate for public office.

- 3. The corporation shall distribute its income for each taxable year at such time and in such manner as not be become subject to the tax on undistributed income imposed by Section 4942 of the Internal Revenue Code of 1988, or corresponding provisions of the subsequent Federal tax laws.
- 4. The corporation shall not engage in any act of self-dealing as defined in Section 4941(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal Tax laws.
- The corporation shall not retain any excess business holdings as defined in Section 4943(c) of the Internal revenue Code of 1988, or corresponding provisions of any subsequent Federal Tax laws.
- 6. The corporation shall not make any investments in such a manner as to subject it to tax under Section 4944 of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal Tax laws.
- 7. The corporation shall not make any taxable expenditures as defined in Section 4945(d) of the Internal Revenue Code of 1986, or corresponding provisions of any subsequent Federal Tax laws.
- 8. Notwithstanding any of the provision of these Articles, the corporation shall not carry on any activities not permitted by an organization exempt under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may be amended, or by any organization, contributions to which are deductible under Section 170(c)(2) of the Code and Regulations as they now exist or as they may be amended in the future.
- 9. Upon dissolution of the corporation or the winding up of its affairs, the assets of the corporation shall be distributed exclusively to charitable religious, scientific, testing for public safety, literary, or education organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its Regulations as they now exist or as they may be amended in the future.

#### ARTICLE IV - MANAGEMENT OF CORPORATE AFFAIRS

The powers of this corporation shall be exercised, its properties controlled, and its affairs conducted by a board of directors. The number of directors shall be as are set forth in the bylaws, in no event shall the number be less than three. The duties, responsibilities, method of appointment and term of the directors shall be set forth in the bylaws.
