**BOARD OF DIRECTORS TERMS**

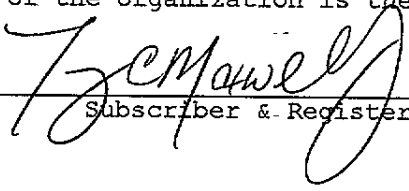

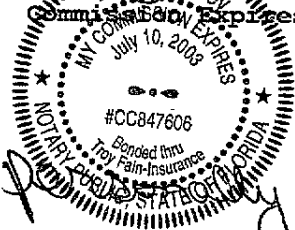
