NAME: The name of the corporation shall be Rural Community Education Center, Inc.

ARTICLE II

ARTICLE III

CORPORATE NATURE: This is a non-profit corporation organized under the laws of the State of Florida pursuant to Chapter 617, Florida Statutes.

This corporation is organized exclusively for charitable, educational, social service, and health purposes. Our mission is to strengthen families and children at risk by strengthening the parent child relationship and the communities in which they live, as well as the disabled and the elderly.
