ARTICLES OF INCORPORATION

In Compliance with Chapter 617.F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: *Northview Assembly of God, Inc.*

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

- 1. Establish and maintain a place for the worship of Almighty God, our heavenly Father;*
- 2. Provide for Christian fellowship for those of like precious faith, where the Holy Spirit may be honored according to our distinctive testimony; and*
- 3. Assume our share of the responsibility and the privilege of propagating the gospel of Jesus Christ by all available means, both at home and in foreign lands. .*
