ARTICLES OF INCORPORATION

I, the undersigned natural person over the aged of eighteen, (18), acting as an incorporator, adopt the following Articles of Incorporation of THE REPUBLICAN NATIONAL HISPANIC ASSEMBLY OF CENTRAL FLORIDA, INC., (the organization).

Article 1

NAME

The name of this organization shall be THE REPUBLICAN NATIONAL HISPANIC ASSEMBLY OF CENTRAL FLORIDA, INC.

ARTICLE 11

NONPROFIT CORPORATION

This is a non-profit organization established pursuant to the Florida Corporations not for Profit Law and shall have no capital stock.

ARTICLE 111

DURATION

The duration of the "organization" shall be perpetual.

ARTICLE 1V

OBJECTIVES

- a. To support the Constitution and laws of the United States of America and the Constitution and laws of the State of Florida to the end that Government shall be truly and, in fact, "A government of the people, by the people, for the people".
- b. To support the principles, objectives and platforms of the Republican Party of the United Stated of America.

- c. To develop and maintain a strong, effective, and informed Republican Hispanic constituency throughout the state.
- d. To encourage able and qualified American Hispanics registered Republican to seek office at all levels of government.
- e. To elect Republican candidates to office at all levels of government.
- f. To develop viewpoints and positions on local, state, and national issues to seek implementation of these viewpoints through local, state and national Republican organizations.
- g. To ensure the participation of citizens of Hispanic heritage in the American political process and the Republican Party.

ARTICLE V

POWERS

Except as otherwise provided in these Articles of Incorporation, the corporation shall have all of the powers necessary and proper to carry out its express powers.

ARTICLE V1

MEMBERSHIP

- a. Voting membership shall be made up of Hispanic, as well as non-Hispanic, registered Republicans (or registered voters in areas where registration is not by party affiliation) who have chosen to be identified with the organization by making and filing an official application at the National Office and paying the required dues.
- b. Guest membership, which shall be a non-voting membership, shall be available to Hispanics and non-Hispanics who for one reason or another are not citizens of the United States, but wish to be identified with the "corporation" by making and filling an official application at the National office and paying the required dues. Guest membership shall also be available to all Hispanics and non-Hispanics who are registered to vote as other than Republicans but wish to be identified with the "organization" by making and filling an official application and paying the required dues.
- d. Associate membership, which shall be a non-voting membership, shall be available to Hispanics and non-Hispanics who for one reason or another do not fulfill the National membership fee, but wish to be identified with the "corporation" by making and filling an official application at the National office and paying the required associate dues.

ARTICLE VII BOARD OF DIRECTORS

- a. The officers of the "organization" shall be the Chairman, Co-Chairman, Secretary, and Treasurer. An Advisor may be appointed by the Board if required.
- b. The officers of the "organization" shall be elected for a term of four (4) years. The officers may be re-elected for a second term. Candidates for these offices shall be nominated from the floor and must have at least two (2) years active in the organization in order to have their names placed in nomination. There shall be no nominating committee. Elections for these offices shall be held in February of each pair-numbers year.
- c. The initial Board members read as follows:

1. Chairman

ARTICLE V111

DUTIES

1. CHAIRMAN

- a. Serve as member of the Executive Committee of the Republican National Committee and a voting member of the "organization".
- b. Serve as the official spokesperson of the "organization"
- c. Preside at all regular or special meeting of the "organization".
- d. Represent the "organization" in all the official events and meetings from the National Executive Committee of the Republican National Committee and its affiliates.

2. CO-CHAIRMAN

- a. Act as temporary Chairman if for any reason the Chairman has resigned or requested a leave of absence.
- b. Responsible for calling meetings of the "organization" for the purpose of electing a new Chairman should an elected Chairman, be unable to called within four (4) months after the Chairman's office has been vacated.
- c. Serve as provisional Chairman for a period not to exceed four (4) months until a new Chairman is elected.

3. SECRETARY

- a. Keep correct minutes of all meetings of the "organization" well as minutes of any committee that established by the "organization".
- b. Maintain all official correspondence of the "organization".
- c. Disseminate all notices of meetings.
- d. Maintain the official calendar of events for the "organization".

4. TREASURER

The treasurer shall receive all moneys paid into the "organization" and pay all bills approved for payment by the board. Other duties of this office will be:

a. Oversee the accurate accounting for all moneys received and disbursed by the "organization".

- b. Prepare quarterly financial reports for dissemination to the "organization" which indicates the financial posture of the "organization".
- c. Oversee the preparation and submission of all state and local financial reports required by the "organization".

ARTICLE 1X

INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial office of the corporation is 1103 Winter Springs Blvd., Winter Springs, Florida 32708. The name of the initial registered agent at this office is Nancy C. Acevedo.

ARTICLE X

CONSTRUCTION AND AMENDMENT

All references in these Articles of Incorporation to statutes, regulations or other sources of legal authority shall refer to the authorities cited, or their successors, as they may be amended from time to time.

Article X1

LIMITATION OF LIABILITIES OF DIRECTORS

A member of the board shall not be liable to the Corporation for monetary damages for an act or omission in the director's capacity as director.
