The undersigned incorporator hereby forms a corporation under Chapter 617 of the laws of the State of Florida.

ARTICLE I. NAME

The name of the corporation shall be:

Sarasota Mobile Home Information Service, Inc.

The address of the principal office of this corporation shall be Post Office Box 8960, Rancho Santa Fe, California 92607, and the mailing address of the corporation shall be the same.

ARTICLE II. NATURE OF BUSINESS


