TO THE ARTICLES OF INCORPORATION OF CHAMPION RESTORATION HEALING AND FEEDING MINISTRY, TAG.

Pursuant to the provisions of Sections 617.1001 et. seg. Of the Florida Statures, undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

- 1. The name of the corporation is Champion Restoration, Healing and Feeding Ministry, Inc.
- 2. The following amendments to the Articles of Incorporation were adopted by the Board of Directors of the corporation on JULY 28,2001 in the manner prescribed by the Florida Business Corporation Act:

"ARTICLE I, is hereby amended as follows:

Lines 1, 2, 3,4, and 5, of ARTICLE I is hereby deleted and is replaced with the following language:

THE NAME OF THIS CORPORATION SHALL BE THE CHAMPION RESTORATION HEALING AND FEEDING MINISTRIES, INC. AND ITS PRINCIPAL PLACE OF BUSINESS SHALL BE IN THE COUNTY OF DADE, STATE OF FLORIDA, OR AT ANY OTHER LOCATION DESIGNATED BY THE PRESIDENT.

"ARTICLE II, is hereby amended as follows:

Purpose

The corporation is organized and operated for charitable and educational purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code.

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c)(3) of the internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law0 or (b) by a corporation contributions to which are deductable under section 170(c)(2) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United states Internal Revenue Law). The objective of this corporation shall be to conduct for charitable, educational and benevolence nature and to engage and establish humanitarian and ohilanthropic activities to the benefit of the under priviledge members of society, creating programs focusing upon the elderly, chronically unemployed, handicapped, substance abused, indigent, economically disadvantaged, ex-offenders,
