Pursuant to the provision of the Nonprofit Corporation Act of the State of Florida and in compliance with Chapter 617, Florida Statutes (Not for Profit), the undersigned incorporators hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of the corporation is: CHRISTIAN WAY FOUNDATION, INC.

ARTICLE II

The name and address of the registered agent and registered office of this corporation is:

ARTICLE III

The purposes for which this corporation is organized: To conduct the activities of a Christian ministry for education of the youth of the world in matters dealing with the word of God.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501 (c) (3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE IV


No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation, except as otherwise provided by Section 501(h) of the Internal Revenue Code, and this corporation shall not participate in, or intervene in any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these Articles.

Notwithstanding any other provision of these Articles, this corporation shall not carry on any other activities not permitted to be carried on (1) by a corporation exempt from federal income tax under Section 501 (c) (3) of the Internal Revenue Code or (2) by a corporation contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code.
