ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) to a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

ARTICLE I

NAME

Purpose(s)

The specific purpose(s) for which the corporation is organized are:

The purpose of this corporation is to illuminate the highest degree of well-founded expectation of good, with the faithfulness of sharing the Gospel of Jesus Christ. Through the collective body of Christians, Praise Services, Prayer, Preaching, Gospel Music, as well as other mediums commensurate in fulfillment of the object of efforts; moreover, it is the ultimate goal of the organization to godfearingly pursue in the Christian Quest for Individual Salvation while communicating the joys, love, and good news of Jesus Christ, our Lord and Savior. Christ Crusaders, Inc., is organized for the purpose of providing health, social or support services to a person with HIV disease or is structured so that a part of the organization is organized for the primary purpose of providing health, social or support services to persons with HIV. care service to children of low-income families and elderly care, as well as a youth intervention program.

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

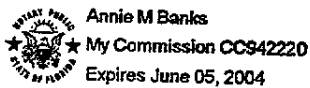
