## **ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator(s) to a corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of Incorporation:

### **ARTICLE I**

#### **NAME**

**The name of the corporation shall be:**

### **ARTICLE II**

### **ARTICLE III**

#### **Purpose(s)**

The specific purpose(s) for which the corporation is organized are:

Christ Crusaders Opa Locka Christian School, Inc., is organized for the purpose of educating all children with a balanced doctrine of biblical and sound teachings. Through the body of Christians, Ministers, Pastors and Theologians. We will provide an educational ministry and philosophy for Kindergartners, Junior High, High School, and College.

### **Manner of election of directors**

The manner in which the directors are appointed is as follows:

Each member must be a Born-Again Believer, seeking the in filling of the Holy Spirit. #### **DISSOLUTION OF CORPORATION**

In the event of dissolution, the residual assets of the organization will be turned over to one or more organizations which themselves are exempt as organizations described in Section 501(c)(3) and 170(c)(2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law or to the Federal, State or Local Government for exclusive public purpose.

Said Corporation is organized exclusively for charitable, religious, educational and scientific purposes, including for such purpose, the making of distributions to organizations that qualify as corresponding provision of any future United States Internal Revenue Law).

Notwithstanding any other provision of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law.

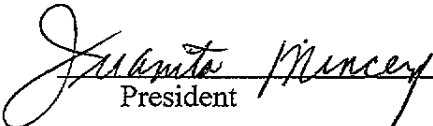

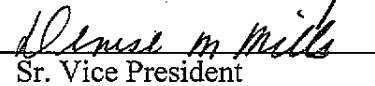
