ARTICLE I. CORPORATE NAME.

The name of this corporation is, AL-FAZAL INTERNATIONAL FOUNDATION, INC., a not-for-profit organization.

ARTICLE II. PRINCIPAL OFFICE.

The principal place of business and mailing address of this corporation is: 11711 N.W. 26TH COURT, CORAL SPRINGS, FL 33065.

ARTICLE III. INITIAL REGISTERED AGENT AND OFFICE.

ARTICLE VI. PURPOSE.

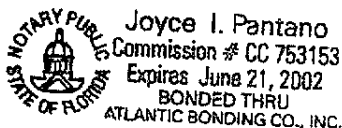
