Enclosed is the Annual Report for the above corporation along with my check in the amount of \$61.25 for the annual report fee.

Prior to June 14, 2002 the corporate office for 704 Second Street was at 1975 East Sunrise Boulevard, Suite 625A, Fort Lauderdale, Florida 33304.

On December 26, 2001 new management was hired to run the building located at 1975 East Sunrise Boulevard, where we had our corporate office. Due to new management, many things changed in the building which included mail delivery problems, telephone line problems and elevator problems.


In January of 2002 the mail boxes were ripped out of the building to make way for a new mail delivery system. I am certain this is the reason I did not receive the initial annual report for this corporation in January of 2002. Had I received the annual report, the fee would have been paid in a timely manner.

On June 14, 2002 this corporation moved out of 1975 East Sunrise Boulevard and into 1001 NE 26th Street. I am terribly sorry we did not pay this fee on time. We would have paid it had we received the annual report. I can only

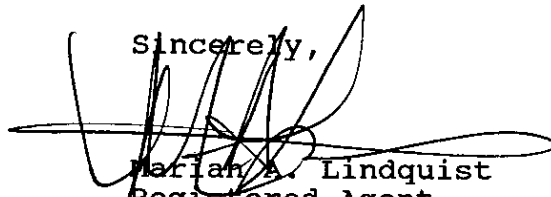
