ARTICLE I. NAME

The name of this corporation shall be **UNIÓN POR SOLUCIONES ALTERNATIVAS PARA EL SIDA, INC.**

ARTICLE II. PRINCIPAL OFFICE

ARTICLE III. PURPOSE

The purposes for which this corporation is organized are:

1) To establish a center offering sick AIDS individuals that want to receive holistic integral health services during the period of intermittent therapy, and also to the diagnosed HIV positive individuals, with modernized natural alternatives and technical medicine of high effectiveness that optimize the functions of the immune system. To facilitate the indispensable resources to have the possibility to improve or to change the lifestyle of the patients, that is necessary to maintain their health through the stimulation of the immune system.

2) To expand, in the future, nationwide and to create subsidiaries in other countries. To provide and to promote informative activities about AIDS and what caused it. To offer alternatives and holistic solutions that do not produce side effects, and to contribute to the health of sick AIDS individuals. To educate, publish, and elaborate, practical and safe programs of prevention for the sick AIDS individuals in the United States. To assure that the treatments that Unión Por Soluciones Alternativas

Para El Sida, Inc. provides, will guarantee patients the methods to stop the risk from being exposed to the stress factors that crate immunodeficiency, and also detoxification of the sick and damaged organs, and to stimulate the immune system with natural products. To create vocational training and technician operated programs with teachers, to offer patients the opportunity to be ready to seek employment, thereby being active and productive individuals for their incorporation into society.


ARTICLE VIII. SCIENTIFIC-TECHNICAL ADVISOR BUREAU


