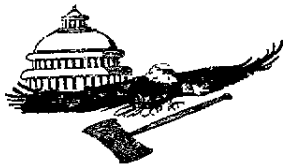

**ARTICLES OF INCORPORATION
OF
FLORIDA BLACK BONDSMAN ASSOCIATION, INC.**

ARTICLE I – NAME

The name of this corporation is FLORIDA BLACK BONDSMAN ASSOCIATION, INC.

**ARTICLE II – PRINCIPAL PLACE OF BUSINESS
AND MAILING ADDRESS**

The principal place of business of the corporation is 201 East Central Boulevard, Orlando, Florida 32801, which is also the mailing address.

ARTICLE III – PURPOSE

The purpose for which this corporation is formed is to defend, organize and discuss issues in the best interests of the African American community as a non-profit organization pursuant to Florida Statute 617.0202.

**ARTICLE IV – APPOINTMENT OF DIRECTORS
AND MANNER IN WHICH DIRECTORS ARE ELECTED**

The Board of Directors will be elected and/or appointed by the initial incorporators. This corporation shall exist into perpetuity unless sooner dissolved by law. However, all new board members will be appointed based on a majority approval of the Board of Directors during a timely noticed meeting with a quorum present. A quorum would consist of at least three (3) board members present. A timely noticed meeting requires every board member to receive notice via certified mail at least ten (10) days prior to the scheduled meeting.

ARTICLE V – INITIAL REGISTERED AGENT

The initial registered agent of the corporation is DEAN F. MOSLEY, ESQUIRE. The initial street address is 20 North Orange Avenue, Suite 1309, Orlando, Florida 32801

ARTICLE VI – INITIAL BOARD OF DIRECTORS

This corporation shall have three directors initially. The number of directors may be either increased or diminished from time to time by the by-laws but shall never be more than five (5) nor less than three (3).

ARTICLE VII – NAME OF INITIAL DIRECTORS

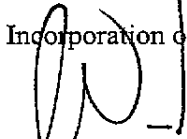
ARTICLE IX – PROPERTY

ARTICLE X – TERMINATION

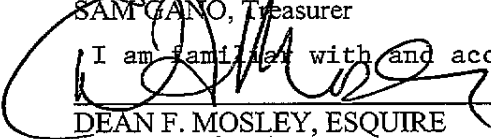

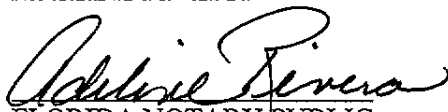
