ARTICLES OF INCORPORATION OF THE RIVER CITY CHRISTIAN CHURCH, INC.

(A Corporation Not For Profit)

We, the undersigned, with other persons being desirous of forming a corporation for religious, charitable and philanthropic purposes as defined under the provisions of Chapter 617 of the Florida Statutes do agree to the following:

ARTICLE ONE: NAME

The name of this corporation is: The River City Christian Church, Inc.

ARTICLE TWO: PURPOSE

The church revealed in the New Testament was ordained of God (Daniel 2:44); established by Christ through His Apostles (Matthew 16:16-19, Ephesians 2:19-22, 1 Corinthians 3:11); and is the pattern for our church in all things, including nature, purpose, and function.

What God accomplished in and through the first Church He longs to accomplish in every age of history until Christ comes again. (Matthew 28:18-20; Acts 1:6)

It is our purpose to be that church, no more and no less, in order that we might worship God wholeheartedly and accomplish His will effectively. This objective, i.e., to restore the church as it was in the beginning, identifies us historically with the Restoration Movement.

To this end it shall have the following powers:

- A. To draft Bylaws supplemental to these Articles which shall define in detail how this corporation shall function with regard to Membership, Officers, Meetings, Leadership, Committees, Parliamentary Authority, and Amendments.
- B. To employ such ministers and personnel as is necessary to the carrying out of its mission;
- C. To own, buy, sell, exchange, convey and lease real estate where the same shall be deemed necessary or desirable in the furtherance of the work of the Church;
- D. To obtain loans upon said real-estate or other security and manage and protect such property and loans and all interest and claims regarding the same;
- E. To insure against loss by fire and other casualties;
- F. To establish and maintain facilities and property suitable for worship, education, fellowship, ministry, and recreation;
- G. To receive and utilize gifts and bequests for the furtherance of the objectives of the corporation.

This corporation recognizes the Bible as the Word of God and the New Testament as its authority in all matters pertaining to the church. It declares itself to be a free and autonomous body, claiming the right of free government and recognizing no outside religious authority or control. We shall have no creed but Christ, follow no book but the Bible, and wear no name but that of our Lord. In matters that our essential we shall have unity; in matters of opinion we shall enjoy liberty; and in all things we shall express love.

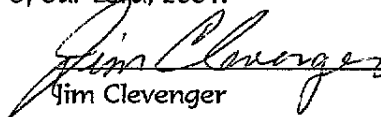
ARTICLE FOUR: TAX EXEMPTION

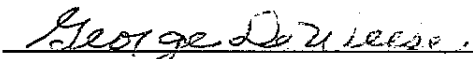

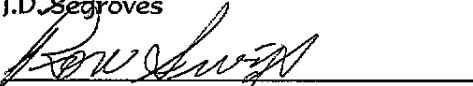
