**ARTICLES OF AMENDMENT
TO THE ARTICLES OF INCORPORATION
OF EXPLORING BIBLE TIMES, INC.**

Pursuant to the provisions of Section 617.1006 of the Florida Statutes, **EXPLORING BIBLE TIMES, INC.**, a Florida corporation (the "Corporation"), adopts the following Articles of Amendment to its Articles of Incorporation:

1. The name of the Corporation is **EXPLORING BIBLE TIMES, INC.**
2. The original Articles of Incorporation for the Corporation were filed on March 2, 2001, and assigned Charter No. N01000001476.
3. By a written consent executed effective March 7, 2001 by the directors of the Corporation, the directors have approved, authorized and directed that the Articles of Incorporation of the Corporation shall be amended to change the name of the Corporation to "**PRESERVING BIBLE TIMES, INC.**" There are no members entitled to vote on the amendment, and the amendment was adopted by the board of directors.
4. Article I of the Articles of Incorporation is hereby amended to read as follows:

ARTICLE I - NAME

The name of this Corporation shall be **PRESERVING BIBLE TIMES, INC.**
