

Dear Sir or Madam:

Enclosed are the revised Articles of Amendment to Articles of Incorporation for the non-profit organization referenced above. Our payment via check number 378 in the amount of \$35.00 is on account with your division having cleared our bank on August 15, 2018.

Our original submission was returned with your letter dated August 14, 2018, a copy of which is enclosed. We have corrected our omission of "Inc." from the company name in the title. Thank you.

Although we have made the revisions you require to the titles in the officer/director fields we do so under protest. You force us to omit one of our officers, the Immediate Past President. We referred to the suggested website and spoke to two agents in your division. Contrary to Florida law, my secretary was advised that Immediate Past President is not an office to be designated and D (Director) would have to suffice.

This is legally incorrect and a change from your past requirements. Please see enclosed detail page. The Immediate Past President is more than a director, she is an officer. In order to become Immediate Past President she must serve a minimum of five years on the board, three of them as an officer.

We are making this change at your direction even though your procedures force us to ignore a legitimate officer position with no legal basis for doing so. In my 37 years of representing business in Florida this is my first letter of complaint to your division. Apparently, convenience now outweighs legal accuracy.


