The undersigned, acting as the incorporator of ORLANDO SNIPERS BASEBALL, INC., a Florida not-for-profit corporation (the Corporation under the Florida Not For Profit Corporation Act (the "Act"), submits the following Articles of Incorporation.

#### **ARTICLE I - NAME**

The name of this corporation is Orlando Snipers Baseball, Inc.

#### **ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS**
