The undersigned, acting as the incorporator of ORLANDO SNIPERS BASEBALL, INC., a Florida not-for-profit corporation (the "Corporation" under the Florida Not For Profit Corporation Act (the "Act")), submits the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is **Orlando Snipers Baseball, Inc.**

ARTICLE II - PRINCIPAL OFFICE AND MAILING ADDRESS

The address of the initial principal place of business of the corporation is 2302 Babbitt Avenue, Orlando, Florida 32833. The initial mailing address of the corporation is 2302 Babbitt Avenue, Orlando, Florida 32833.

ARTICLE III - PURPOSE

The Orlando Snipers, Inc. is a youth baseball educational organization. This Corporation is organized and shall be operated as a nonprofit organization under the Act exclusively for the purpose of promoting a common business interest as described in Section 501(c)(6) of the Internal Revenue Code of 1986, as amended, or any corresponding provision of any future United States Internal Revenue law (the "Code"), and conducting any and all lawful affairs for which a Florida nonprofit corporation may be incorporated under the Act; provided, however, that the Corporation may not engage in any activities not permitted to be carried on by a corporation described in Section 501(c)(6) of the Code.

ARTICLE IV - MANNER OF ELECTION

The Directors of Orlando Snipers, Inc. have been duly appointed.

No part of the net earnings of the Corporation shall inure to the benefit of, or be distributed to, its directors, trustees, officers or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III above.

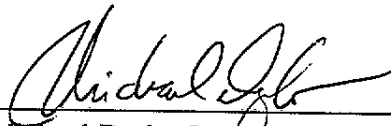
ARTICLE VIII - INCORPORATOR

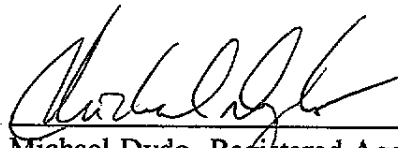
Pursuant to Section 48.091 and Section 607.0501, Florida Statutes, the following is submitted:
