## ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

### ARTICLE I      NAME

The name of this corporation shall be **Partners For Students with Disabilities, Inc.**

This corporation is organized exclusively for charitable purposes within the meaning of Section 501(c)(4) of the Internal Revenue Code of 1986, as now enacted or hereafter amended, including, for such purposes, the making of distributions to organizations that also qualify as Section (c)(4) exempt organizations. To this end, the corporation shall develop, evaluate, and disseminate programs that foster independent, social, services, and recreational activities for individuals with mental or physical disabilities and of their families. **Partners For Students with Disabilities Inc.** seeks to enhance the lives of people with disabilities so that these individuals and their families can live a more productive and spirited life. We strive to assist these individuals in establishing pro-social values such as kindness, helpfulness, personal responsibility, and respect for others, qualities we believe are essential to leading humane and productive lives in our community and society.

### ARTICLE IV      MANNER OF ELECTION OF DIRECTORS

The qualifications for Directors and the manner of their admissions shall be regulated by the by-laws. The management and affairs of the corporation shall be at all times under the direction of a Board of Directors, whose operations in governing the corporation's by-laws. No Director shall have any right, title, or interest in or to any property of corporation.
