ARTICLES OF INCORPORATION
In Compliance with Chapters 617, F.S. (Not for Profit)

The undersigned incorporator, for purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I: NAME

The name of the corporation shall be: Americans Fighting for Equal Access, Inc.
