Dear Sir or Madam:

The law involving registered return receipt establishes the condition where requirements crossed in the mail; and, as per your important facts, were "to be disregarded". Follow-up #003A00056516 returned the filing and retained payment as included in registered return receipt. The primary board member was out of the country detaining approval for inclusion of his "new residential address" for the annual filing. At the time he returned, the computer locked us out. Currently not funded, we work full time to eventually benefit all child with development.

The law specifies execution at the time of dated posting within USPS as proof of the material intent of the sender i.e. the print-out tracking of the USPS with transmittal date of 10/10/03 which meets important facts sheet specificity of "crossing in the mail". Received, paid, and filed: 10/15/03 with PMO 10/10/03 effective date.

Columbus Day fell on Monday between transmittal and receipt and probably why the office was required to complete the batching required of them before this holiday. Were requirements which "crossed in the mail" given due consideration? The registered return receipt materials were returned "prior to cancellation date in notification" with additional requirement to complete a reinstatement form which per your important facts should be moot.

This letter is per request of intake specialist to include a reason for effective reinstatement with a waiver, since, first, all materials were in the USPS 10-10-03 with the required forms, and second, two notices which should have come to inform the corporation of impending cancellation did not arrive. According to your materials, if requirements crossed in the mail; then, disregard this cancellation notice. The Registered Agent, challenged with a personal health issue at this time, requests consideration for a waiver of fees and requests reinstatement as specified.
