Articles of Incorporation Of Friends of Lake Bell, Inc.

In compliance with the requirement of Chapter 617, Florida Statutes, the undersigned, all FRIDA of whom are residents of Florida and are competent to contract, have voluntarily associated themselves together for the purpose of forming a corporation not for profit and do hereby certify:

Article I

The name of the corporation is Friends of Lake Bell, Inc.

Article II

The principal office of the Corporation is located at 1033 Lake Bell Drive, Winter Park, FL 32789.

Article III

Purpose of the Corporation

Friends of Lake Bell, Inc. is Not-for Profit organization whose purpose is to exercise and promote the health, conservation and welfare of Lake Bell and its surrounding wetlands and the surrounding community in matters involved with the City, County, State and Federal Governments. The objectives of this organization are to monitor businesses, corporations, city/county authorities, organizations, or any other entities to ensure any affecting programs will maintain or improve the water and environmental qualities of Lake Bell and its adjacent lands. The Friends of Lake Bell, Inc. has the right to exercise all the powers and privileges and perform all of the duties and obligations of the Corporation as set forth in this article including, but not limited to;

(a) acquire (by gift, purchase or otherwise) own, hold, maintain, convey, sell transfer real
or personal property in connection with the realization the affairs and goals of the
Corporation;

- (b) borrow money with the assent of two-thirds of the Members by means of mortgage, pledge, deed in trust;
- (c) dedicate, sell or transfer all or any land acquired in correlation with the purpose of the Friends of Lake Bell, Inc. No such dedication, sale or transfer shall be effective unless two-thirds of he Members agree to such dedication, sale or transfer;
- (d) have and exercise any and all powers, rights and privileges that a corporation organized under the laws of Florida applicable to corporations not for profit may now and hereafter have or exercise.

Article IV

Members

The members of the Corporation are formed by all homeowners of those lots abutting the shoreline of Lake Bell in Orange County, Florida.

Article V

Voting Rights

The Members of the Friend of Lake Bell, Inc. will have one class of voting membership. One vote is allocated per household of the members.

Article VI

Board of Directors

The Board of Directors will consists of seven members, elected annually by the members of the Friends of Lake Bell, Inc. The Board of Directors will elect the Officers consisting of President, Vice President, Secretary, and Treasurer within the ranks of the Board of Directors. The names and addresses of the persons who are to act in the capacity of directors until the first annual voting and election of directors by the members of the Friends of Lake Bell, Inc. and their addresses are as follows:

Article X

Adoption and Change of ByLaws

- (a) by the Board of Directors at a regular or a special meeting in which all the Board of Directors are present with a majority vote, or;
- (b) by the Members of the corporation at a regular or special meeting at which a majority vote of the total members of the corporation would be required.
