## ARTICLES OF INCORPORATION:

(In Compliance with Chapter 617, F.S., (Not for Profit)

### ARTICLE I NAME:

The name of the corporation shall be:
WORK OPPORTUNITY for WOMEN TEAM, INC.

#### ARTICLE II PRINCIPAL OFFICE:

The purpose for which the corporation is organized is:

To provide information, inspiration, and training for women entrepreneurs on starting and running their business and/or supplementing their income with a business opportunity while providing financial and resource support directly related to employment and business related activities (including work-related childcare services as needed), under a structured corporate program of receipient performance accountability. Efforts will be attempted to exhaust all available resource support from other social service and governmental programs prior to providing individual case-by-case needs. All funds provided by the corporation will be paid directly to the appropriate source of the related needs in every effort to preclude direct payment to the applicant/receipient contingent on monitored receipient performance accountability. Upon determination of lack of receipient performance within the pilot program such receipient will be terminated in order to be a good steward of the donor/sponspor funds to apply the funds responsibly to those who commit and dedicate themselves to the performance accountability of the programs.

The corporation will provide information, inspiration and education on one key issue close to the founder's heart on the matter of domestic violence, the prevention of violence against women, and sexual harrassment in the workforce.

The corporation will be proactive in holding general public meetings for women to attend and to be introduced into business opportunities and the corporation will be proactive in procuring corporate sponsporships, donations and fundraisers and will provide the appropriate tax-deductible records for all donors and sponsors. Additionally, the corporation allows for future contingencies and protects the right of the corporation to expand future activities: "The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the corporation from extending its activities to any related or otherwise permissible lawful business/non-profit purposes which may become necessary, desirable or non-profitable for the furtherance of the corporate objectives expressed above."

#### ARTICLE IV MANNER OF ELECTION:
