The undersigned incorporators, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopt the following Articles of Incorporation:

ARTICLE I:

The name of the non-profit corporation shall be: NATURE COAST EDUCATIONAL EXPEDITIONS, INCORPORATED.

To provide educational nature programs and wildlife encounters to segments of the population that normally do not have access to such programs due to economic and logistical barriers. These segments of population will include underprivileged children, the elderly and handicapped, low-income minorities, at risk children and young adults, and certain incarcerated individuals enrolled in rehabilitation programs.
