ARTICLE OF AMENDMENT

The Articles of Amendment is executed by the corporation as provided in s. 617.01201 and set forth as follows:

ARTICLE III **PURPOSE**

The corporation is organized exclusively as Urban Assault Ministries, Inc. for one or more purposes as specified in Section 501 (c)(3), of the Internal Revenue Code, including, but not limited to plans to establish the WORLD WIDE MINISTRY in the following areas:

Urban Assault Ministries Temple of Praise

Urban Assault Ministries Temple of Praise will promote the assembly of men, women, and children collectively, as a family, and individually as needed, for fellowship, edification, praise, prayer, bible study, counseling, and regular worship services to instill faith and spiritual growth according to standards set forth in the Holy Bible 1611 King James Version.

Ground Breaking Truths Radio Outreach Ministry

Ground Breaking Truths has been designed to be a type of bible study, in which everyone in the listening area are encouraged to study along. This broadcast is aired weekly, in a 30 minute time slot, and covers the Tri-state area, NW Florida, SE Alabama, and SW Georgia. This broadcast will also offer sermons, prayer, and counseling from a biblical prospective to the listening area as a way to reach God's people through His Word as manifested in the Holy Bible 1611 King James Version. Listeners are encouraged to send in praise reports and prayer requests.

ARTICLE VIII LIMITATIONS OF CORPORATION

This corporation is organized exclusively for charitable, religious/spiritual, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

USE OF INCOME

No Part of the net earnings of the corporation shall inure to the benefits of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the above paragraph.

GENERAL LIMITATION ON NON-PROFIT ACTIVITIES

Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code, or the corresponding section of any future federal

tax code, or (b) by a corporation, contributions to which are deductible under section 170 (c)(2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

ARTICLE XI DISSOLUTION PROVISION

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c)(3) of the Internal Revenue Code, or any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

The amendment to Article III and Article V of the Articles of Incorporation, and the addition of Articles VIII,IX,X,XI, were considered and discussed and, on a motion duly made and seconded, it was unanimously.
