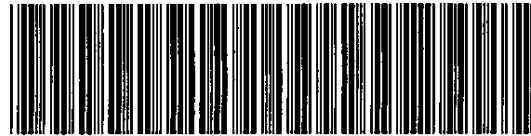

ARTICLE OF AMENDMENT

The Articles of Amendment is executed by the corporation as provided in s. 617.1006 and set forth as follows:

The name of the corporation: **URBAN ASSAULT MINISTRIES, INC.**, a 501 (c)(3), Florida Corporation, filed on March 13, 2001, subsequent amendment filed April 22, 2002, as shown by the records of the Division of Corporations, Department of State, as document # N01000001770.

The text of the amendment:

ARTICLE III PURPOSE - ADDENDUM

The corporation is organized exclusively as Urban Assault Ministries, Inc. for one or more purposes as specified in Section 501 (c)(3), of the Internal Revenue Code, including, but not limited to plans to establish the **WORLD WIDE MINISTRY** in the following areas:

New Heights Nouthetic Counseling

New Heights Nouthetic Counseling will be designed, developed and established to provide spiritual counseling to individuals, families and groups within and outside any religious affiliation. All counseling sessions will be guided by the Holy Spirit and the Holy Bible 1611 King James Version. New Heights Nouthetic Counseling will operate under the auspices of the church and will have authorization to make referrals as needed to New Heights House of Hope and/or New Heights House of Restoration.

New Heights House of Restoration

New Heights House of Restoration (NHHOR) when operational will be established to provide victims of domestic/sexual violence, individuals and families, safe shelter and care physically, emotionally, and spiritually. NHHOR will minister biblical principles based on the Holy Bible 1611 King James Version, and apply tools to equip such as educational and vocational assistance, to help victims to achieve reformation of life from the effects of violence and abuse.

New Heights House of Hope

New Heights House of Hope (NHHOH) when operational, will be established as a faith-based residential care facility which provides physical, emotional and spiritual care to troubled, hurting teens and spiritual counseling to their families. NHHOH will minister restoration and reconciliation of relationships in the lives of troubled, hurting teens and their families. NHHOH will provide a family, home-like setting for resident teens aged 13-18. NHHOH will also provide educational services and programs which will consist of State required/approved academics to include biblical teachings based on the Holy Bible 1611 King James Version. NHHOH will have an affiliation, support and guidance with the National House of Hope based in Orlando, Florida.

Women of Distinction Association

Women of Distinction (WOD) will be established as a National/International women's outreach ministry to serve the needs of individuals, groups, communities and nations throughout the world. WOD will host at least 1-2 major fundraiser events as a sponsorship to NHHOH and to NHHOR each. WOD will also cover all current and future women's conferences under the auspices of Urban Assault Ministries, Inc.

The amendment to Article III and Article V of the Articles of Incorporation were considered and discussed and, on a motion duly made and seconded, it was unanimously.

RESOLVED, the aforementioned amendment to the Articles of Incorporation presented in this meeting, be and hereby adopted, effective on June 21, 2006, and supercedes the previous date of any adoption of the Articles of Incorporation.
