THE CHARIS CORPORATION, INC.**


ONE: The name and address of this principal corporation is The Charis, Corporation, Inc., located at 1232 Squirrel Lane South, Jacksonville, Florida 32218, in Duval County. The principal office is also the mailing address and the address of the registered agent. The corporation is organized pursuant to the FLORIDA Nonprofit Corporation Code.

TWO: This corporation is a nonprofit public benefit corporation and is not organized for the private gain of any person. The corporation is organized under the Nonprofit Public Benefit Corporation Law for, charitable and educational purposes to aid the poor and disadvantaged individuals and families toward a life of self-sufficiency. The programs will consist of but shall not be limited to: Land, Acquisition, Counseling, To provide Child Care Services, Tutoring Adult Day Care, Care for disabilities, Twenty-Four Hour Day Care, School grades K - 3, Low Income Housing, Homeless Shelter, Teen Job Placement, Teenage Pregnancy, Tutoring, Summer Camp, Community Employment, Before & After School Care, class/homework assistance, Computer Lab, Math and Science Lab, Drama and Arts, Arts, Music, Seminars, Health Fairs, Aids/HIV Education, Drug Awareness, Rehabilitation of clients back into society, Prison Reform and other programs to aid those in need.

THREE: The duration of this corporation shall be perpetual, no stock and shall have no members.



Any such asset not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is located, exclusive for such purposes or to such organized and operated exclusively for such purposes.
