ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation, in compliance with Chapter 621, F.S.

ARTICLE I: NAME

ARTICLE III: PURPOSE

The purpose for which the corporation is organized is:

To provide a civic, educational, charitable and benevolent organization for the exchange of ideas, information, education, knowledge, and training among governmental Inspectors General.

To Foster and promote public accountability and integrity in the general areas of the prevention, examination, investigation, audit, detection, elimination and prosecution of fraud, waste and abuse, through policy research and analysis; standardization of practices, policies, conduct and ethics; encouragement of professional development by providing and sponsoring lectures, debates and other educational programs; and the furtherance of professional qualification, certification and licensing.

ARTICLE IV: MANNER OF ELECTION OF DIRECTORS

The manner in which the directors are elected or appointed is:

Directors are elected from among the eligible members of the chapter. Each director shall serve a three year term. Nominations to fill vacancies on the Board of Directors are made by the nominating committee. Candidates in numbers equal to the number of vacancies receiving the largest number of cast votes will fill the vacancies.
