ARTICLES OF INCORPORATION

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:

Precinct 50 Neighborhood Association Incorporation

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose for which the corporation is organized is:

The purpose of the Association shall be to enrich the quality of life for all persons residing in Precinct 50 by working to do the following:

1. Develop a desire for neighborhood improvements.
2. Engage in educational, civic, and social activities to stimulate neighborhood improvements that will include getting to know each other better; working together; sharing information; discussing our concerns, solving our problems; supporting our individual and group goals and activities; celebrating our successes; and cooperating with other community groups while striving to exchange the current reality of poor neighborhood conditions with our shared vision for good community support and a better neighborhood environment.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

1. At the first regular meeting in April of every year, beginning in 1998 and every year thereafter, A Nominating Committee of five members shall be elected by the Association. It shall be the duty of this committee to nominate candidates for the offices to be filled at the annual meeting in June, additional nominations from the floor by members of the Association shall be permitted.
2. The officers shall be elected by secret ballot to serve for two years or until their successors are Elected, and their term of office shall begin at the close of the meeting at which they are elected.

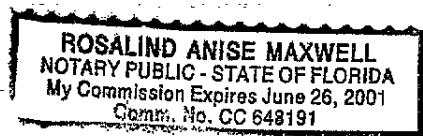
